AGREEMENT OF DEFENDANT AND ORDER DEFERRING DISPOSITION

Pursuant to 17-A M.R.S. § 1901 et seq., I am the above-named defendant, I have entered a plea of guilty, and I agree to:

- 1. Appear in the court on the date and time I am notified to appear.
2. Refrain from all criminal conduct and violation of federal, state, and local criminal laws.
3. Identify myself as being on deferred disposition if arrested or questioned by law enforcement and notify the District Attorney's Office in writing of any contact with law enforcement within 96 hours of that contact.
4. Advise the court named above of any change in my address or telephone number within 24 hours of the change.
5. Comply with all conditions of the attached Bail Order Conditions of Release Deferred Disposition contract.
6. Pay an administrative supervision fee of \$\_\_\_\_\_ per month.
7. Have no contact with male female children under the age of \_\_\_\_\_ direct or indirect.

except as is necessary:
