#### PLEA / ANSWER

I understand the charge against me and I plead guilty to / admit the above offense and enclose the fine set forth above. I understand that, by signing below, I am giving up my right to a trial before a judge or jury, to present witnesses and to cross-examine witnesses against me, and to be represented by an attorney. I understand that I am giving up my right to force the state to prove the charges against me by preponderance of the evidence (for a civil violation) or beyond a reasonable doubt (for a crime). I also understand that my signature below will have the same effect as a judgment of the court finding that I committed the offense (if a civil violation) or finding me guilty (if a crime). I realize that this record of having committed a civil violation or record of a criminal conviction may have future consequences, including: leading to higher penalties or elevating the charges if I commit future offenses. In addition, if I am not a United States citizen, I realize that pleading guilty to a crime may have immigration consequences. I have not been pressured to sign this form or waive my rights, and am doing so of my own free will.

In addition, (except for traffic offenses) I understand that by signing below I am swearing or affirming that I meet the requirements for signing this form as those requirements are explained on the attached "Instructions for Form CR-127" page.

You may <u>not</u> use this form to waive your rights if you have plead guilty to, have admitted (with or without an explanation), or have been found guilty of any other **Inland Fisheries and Wildlife** crime <u>or</u> civil offense within the past 12 months. By signing this form, you are swearing or affirming that you meet this requirement and are eligible to sign this form. If you swear that you are eligible to sign this form and it is later discovered that you were swearing falsely, you may be subject to an additional fine of up to \$50.

You should understand that your signature on this form has the same effect as a court judgment finding you guilty of the Inland Fisheries and Wildlife offense listed on this form. If you sign and return this form, a record of your conviction will be sent to the Commissioner of Inland Fisheries and Wildlife.
