NOTICE OF RELINQUISHMENT OF DANGEROUS WEAPONS TO BE COMPLETED BY LAW ENFORCEMENT

The court has issued an extreme risk protection order prohibiting the respondent from purchasing, possessing or receiving a dangerous weapon or having or attempting to have custody or control of a dangerous weapon. A dangerous weapon is defined as:

- 1. Any device designed as a weapon and capable of producing death or serious bodily injury, 17-A MRS §2(9)(C), including
2. A "firearm" as defined as any weapon, whether loaded or unloaded, which is designed to expel a projectile by the action of an explosive and includes any such weapon commonly referred to as a pistol, revolver, rifle, gun, machine gun or shotgun. Any weapon which can be made into a firearm by the insertion of a firing pin, or other similar thing, or by repair, is a firearm, 17-A MRS §12-A.

The court has ordered the respondent to relinquish any dangerous weapons to law enforcement. Law enforcement must complete and forward this form to the court within the next business day after the following:

- 1. Service of the order; and
2. Taking possession of any dangerous weapons; or contact with the respondent who was already subject to a restriction order and has already relinquished any dangerous weapons to law enforcement.

Respondent relinquished dangerous weapons to law enforcement.
